(NYSE:VAS, a global leader in respiratory, neurological and medical/surgical technologies. Randy founded VIASYS in 2001 and led the consolidation of 15 independent companies and the subsequent public offering on the New York Stock Exchange. In mid 2007 VIASYS was acquired by Cardinal Health Inc. in a transaction which represented a fourfold increase in enterprise value over the five years the company was public. Randy was named an Ernst and Young Entrepreneur of the Year in healthcare technology in 2007. VIASYS was named by Smart Money magazine as one of the ten best investments for the decade.
